Jean Jokinen gave verbal comment to follow the residence territories from the Constitution. She feels you cannot just pick the two counties of Baraga and Marquette because it is not fair to those tribal members that live in other counties.

Jennifer Misegan gave verbal comment that the intention of the Ordinance, which she brought forward, was to continue with the two counties that were already covered for several years and the age has always been eighteen and over.
