 - a) Legislative Update Same Sex Marriage

Doreen gave an update related to Same Sex Marriage, which was passed by a referendum vote. The Attorney's Office is working on this and the areas that would need to be addressed are marriage, divorce, custody of children, pension, and marriage fraud. The attorneys believe it will be ready to go through the Legislative Process by next month.

President Swartz stated the Council will be meeting with the Department of Justice, U.S. Attorney General's Office to discuss the regulation of marijuana, also passed by referendum vote. The meeting will take place at KBIC in late April.

Vice President Misegan stated that while in Washington DC she attended a session with the U.S. Attorney General from Colorado and Washington, where they have legalized marijuana for recreational use, and they stressed that Tribes will not be able to go any farther than their States will allow. Possession is still against Federal Law.
