 Doreen Blaker, Treasurer – 1st Reading Proposed Ordinance 2015-03 Introduction of Medical Marijuana

Doreen introduced the proposed Ordinance 2015-03:

An ordinance of the Keweenaw Bay Indian Community enacted under the authority of the Constitution and By-Laws of the Keweenaw Bay Indian Community for the purpose of creating an exception to Tribal Code §3.1706 Controlled Substances and allowing a person to possess Medical Marijuana in compliance with the Michigan Medical Marihuana Act.

§3.1707 Medical Marijuana Exception. Any person who is a qualifying patient or a primary caregiver under the Michigan Medical Marihuana Act and possesses on his or her person a valid registry identification shall not be subject to arrest, prosecution or penalty for possession of marijuana if that possession is in compliance with the Michigan Medical Marihuana Act.

§3.1708 Unauthorized Sale of Medical Marijuana. No registered qualifying patient or registered primary caregiver may sell marijuana to someone who is not a registered qualifying patient with a valid registry identification card.

A conviction upon a violation of the provisions of this section shall constitute a conviction of a Class D misdemeanor and along with any other penalties for the sale of marijuana. In addition, the Tribal Police and the Tribal Prosecutor may work with state law enforcement officials to revoke the person's registry identification card.
