She believes it is necessary in providing successful operations of the Tribal businesses. This was also discussed at a Finance meeting and she has a model from Lance Morgan (Ho-Chunks) to follow. It would help the Council to be more effective and efficient in Government functions. There is a 1985 Resolution/Charter for the corporation, but it needs to be examined and changes can be made.

President Swartz commented the Tribes that do separate are the ones that are most successful.
