Discussion was on the issue of HUD attorneys unwilling to accept land leases and problems with trust properties. The only place to receive funding is through USDA and the Chippewa Valley Bank for Section 184 Loan Guarantee Program.

The Council would like to meet with Jeff Sachs at I.H.S. and Brian Willoughby, E.I.T. to discuss the issue of projects and why there is a delay in the waterline projects.

Jennifer Misegan had changes on page 23. 'Family Independence Agency' should be changed to 'Department of Human Services' and the listing of the four heating assistance programs, change 'Inter-Tribal Council of Michigan' to the Tribe's 'Community Assistance Program' through LIHEAP.

The Indian Housing Plan must be submitted by the end of June to HUD.

b) HUD – ICDBG/NAHBG (Native American Housing Block Grant) Program Funding

OHA submitted a grant from NAHBG stimulus money for \$2 million for low income home ownership in the Beartown Development and will be funded on a first come first serve basis.

## Mike returned at 10:14 a.m.

Fred Dakota questioned why Housing doesn't offer Tribal members to buy the project homes. He asked if they would send surveys to the people regarding purchasing the homes.

Mike LaFernier stated they could rent to own.

Eddy stated it would be possible but the consequences would be that the homes cannot be serviced by Housing Maintenance.

Sarah Smith stated there is HUD ICDBG stimulus funds available to current grant holders, not specifically for housing that can be used towards the Early Childhood Education Center. The Tribe will have to prioritize the projects.

KBIC will work with OHA to apply for grants under 501.C3 required grants.

The Tribe could have possibly applied also for the new Child Care Center. Housing's application is now first priority. Eddy Edwards stated that due to the scoring in the priority list, it would be risky to withdraw their application. The Tribe will submit a second application.

Susan LaFernier stated that had the Tribe known about the first application the two could have been combined.

Elizabeth Mayo inquired about the information on the authority of OHA and competing against the Tribe that was requested from Mr. Baker. This will be provided later in the day.
