They will recommend either to follow the recommendations of the Visiting Team or they can change their decision. It would then go to the Higher Learning Commission Board in October to make the final decision at that time. The process is proceeding as planned.
 - b) Broadband Technology Opportunity Program Grant through the USDA/Rural Utilities and Department of Commerce – Debbie was notified in June that funding was available and she met with Tom Chosa, Sarah Smith and Jim Stingle and there was a short timeline. Tom Chosa will be submitting a proposal for a broadband system throughout the reservation to the Council. The OCC Board of Regents authorized Debbie to move forward with a grant application for the expansion of their current campus on the south end of the building and they will use it for a public computer center. OCC has applied for \$1,897,560.00 with a 20% cash match. OCC is contributing \$25,000.00, which can be waived.
