L. Recognize Scheduled Delegation/ Individuals:

1. Suz Jondreau/Dan Larson – Baraga Conservation District Presentation. They are applying for a Huron River Watershed Planning/Study grant from the DEQ because of the concern of stream bank erosion and sedimentation on the Huron River. They would like the Tribe to donate \$1000 for the use of the conference room and to help with meals for the volunteers that will be coming in from the colleges and the local areas. They are also asking for \$2000 toward education and training seminars. They would also like a Council member to be an advisory member on their committee. Dan Larson stated that the health of this river has to be in conjunction with the proposed mining, because the exploration has contributed to this concern.

Chris Swartz asked if this would be an avenue for KBIC's environmental concerns to be heard with the DEQ and EPA? Suz Jondreau said it is an outreach that they want to do. Chris said he wants to make sure the mining company is held accountable for destroying the reservation ecosystem. He does not believe that there is *any* sulfide mining process in existence today that does not harm the environment. Dan Larson said he believes that the Tribe partnering in conjunction with the DEQ and EPA will have "more bite" in this fight.

He reminded the Council that when the plan first came to the Council the cost to the Tribe was going to be \$69,000 in cash match and the remaining of the total \$125,000 match would be in-kind matching funds. The project is now coming in at \$500,000. Meetings have been held to bring the project back into budget, with input from the Cultural Committee, the sewing group and members of the Seniors.
