George DeCota was concerned about fire hazards on the rez as he has seen yards that need to be cleaned up. Doreen Blaker asked him to bring a proposal to the Council and to identify the areas that need to be cleaned. Gary Loonsfoot mentioned working in conjunction with OHA during their Spring Clean-Up.
