Edited Paragraph 29.101 Automatic Expungement #2: The person was not *impaired by marijuana* while operating a motor vehicle at the time the offense was committed. #6: If at the time of the offense the person possessed more than 12 plants or exceeded other personal use limitations set by Michigan Law, the person possessed an active registry identification card as a primary caregiver at the time of the offense, did not exceed the amount of marijuana or plants allowed for primary caregivers under Michigan Law at the time of the offense, and was otherwise compliant with Michigan's primary caregiver laws.
