The initial cost of the project was \$800,000.00 and Sarah presented a budget for total construction of \$1,118,125.00 which included a full basement (I.H.S. recommendation) and an additional \$33,000.00 for Solar Electric. The Council instructed Sarah to bring back a revised plan within the budget.
