b) Tribal School Information/Amy St. Arnold, Education Director

Amy, President Swartz, Larry Denomie, CEO, and Susan LaFernier met with Tim Miller from the Hannahville Indian School for input on charter schools. He offered pros and cons of a charter school and estimated costs to fund the school along with the estimated cost of conducting a community survey. The startup cost is estimated at \$5 million and will take approximately \$2 million yearly to operate a school of 150 students. The school must follow the state rules and must state what will be different than what the public schools have to offer.

Larry Denomie suggested a door-to-door survey. The approximate cost for the survey is \$3,000.00 and may be paid from the ANA Grant.
