*§10.501 (16) of Title 10 of the Tribal Code shall be amended to read as follows:* 

16. "Small game" means rabbit species and squirrel species.

*§10.5101 (A) (6) of Title 10 of the Tribal Code shall be amended to read as follows:* 

6. Other fur bearing animals: All other fur bearing animals not listed may be taken by trap between 10:00 a.m., September 1st to 11:59 p.m., March 31st, provided that raccoons which have become a nuisance on residential property by causing damage to the property may be trapped at any time by, or with the permission of, the property owner without a license.

*§10.5102 (A) (5) and (6) of Title 10 of the Tribal Code shall be amended to read as follows: 5.* Other furbearing animals: No limit.
