1. <u>MISSION STATEMENT</u>: To provide exceptional services for our membership; a safe, positive work environment for employees and sustained economic prosperity, while protecting our sovereignty and preserving our culture and natural resources for future generations.

VISION STATEMENT: A Tribe that preserves the Anishinaabe culture, advances economic diversity, provides opportunities to enhance independence, and promotes the health and well-being of our Community.

- 2. <u>Updates:</u> During December, there were many routine items to attend to. It was a short month due to taking vacation and enjoying the holiday days given by the tribe. I have started our office moving towards a paperless environment and am currently working with a team to review some workflow and document management solutions. I met individually with several of the departments to give guidance on decisions made by the appeals officer, budgets, procurement, time management, contracts, grants, and staffing.
- 3. <u>Meetings/Conferences</u>: I attended the Indian Health Service 2021 Budget formulation meeting in Green Bay during the beginning part of December. This meeting was for tribes to provide input on their priorities for funding. A tribal caucus was held with leaders and staff attending from the majority of the Bemidji Area tribes. A BIA budget formulation request from our tribe will be brought forth next week for consideration. Each tribe was allowed to give their input as to where priorities should be placed. There were updates given by the National Indian Health Board and Indian Health Service. A tribal consultation is currently out for tribes to provide input on the hiring of a permanent Director. I attended the Community meeting held the second week of December to provide updates on the progress of the Halfway House project. Normal meeting attended were Health Board, CARE, Community Policing, Halfway House, and Constitution Committee.
- 4. Employee Changes: There have been no changes with any department heads during the month of December other than moving several out of their probationary status. There remains three department heads to have employee reviews completed for their probationary period. There has been change in management of the following departments this past year: Fire/Emergency, Community Assistance Programs, Social Services, IT, Natural Resources, Health, Personnel, OVW, and Convenience Stores. The Health department and Natural Resources departments are currently looking at restructuring and reclassifying many of their employees.
- 5. <u>Statistical Data/Case Load Information</u>: There are 26 department/businesses currently supervised by the CEO's office. As of the last update given by HR and Personnel, there are 600 employees working for the Tribe.
- 6. <u>Financial Update:</u> The federal government remains in shutdown. We have received notice from a few of the agencies that we can still access funds through their electronic systems. The governmental operating budget relies on approximately ½ of its funds from grants and contracts. We have some requests for overpayment from Indian Health Service for past years payment of Contract Support Costs and from the Department of Housing and Urban Development for disallowed costs. Medicaid funds outstanding to our Substance Abuse Programs have been settled from past years of 2009 through 2016. The total amount settled was \$557,588. There remains 2017 and 2018 to settle. Our Substance Abuse Programs are currently working with the state of MI to move forward with direct billing and are paving the way for other tribes. I would like to thank Jeanne Hirzel, Danielle Webb and their staff on moving this outstanding issue along.
