Vice President's Report July 2018

- I attended a work group formed to develop a grant application from the Substance Abuse and Mental Health Services Administration or SAMHSA to fund the Tribal Opioid Response. The work group includes several medical providers from our clinic, the new Health Director, the CEO, Grant Writer, Substances Abuse programs, Police Department, Drug Court and Social Services. The grant is to develop a medically assisted treatment program and I believe the focus will be pregnant mothers. The Health Director will be leading the group. The application is due August 20.
- I participated in our first construction meeting with Gundlach Champion for our casino projects. Several issues were discussed including: BIA Roads approvals, SHIPO required archeological study, the status of all necessary permits, Chocolay Township and the water tank. We also discussed the water main break in Baraga and the settlement that has been reached regarding the lost revenue and the cost of the repairs. A Job Fair will be held on August 8 at the Marquette property. They are looking for Laborers, Carpenters, Plumbers, Ironworkers, Operators and Electricians. If you know of someone looking for work, please send them there between 10 am 1 pm and 3 pm 7 pm.
- The KBIC Tobacco Company held a Board meeting on July 24. Items on the agenda included: Issues related to paperwork processing of cigarette orders, the operating budget and annual plan, a schedule for financial reports, development of additional bonded facilities, a process for damaged products, the hiring of a Warehouse Supervisor and the gifting of the stamping machine back to the Tribe. We have been receiving a few complaints regarding damaged products and are encouraging everyone to return those products back to the store where they were purchased in the pack and packaging materials they came in. We can tell where and when they were made from the pack. Their product will be replaced.
- I attended the annual Pauline-Knapp Spruce Memorial Water Walk to raise awareness for our water. It was an absolute beautiful day, a beautiful ceremony and attended by many beautiful people. Chii Miigwech to those who organized it and assisted with it, especially Terri Denomie and Kathleen Smith. Each year I get to spend a little more time than the year before, hopefully, someday I will have the honor of finishing it.
- I had the honor of sharing our Pow wow with Congressman Jack Bergman and his Communication Director, James Hogge. They both loved it. The Veterans were kind enough to include the Congressman and he participated in the grand entry by carrying the American flag. He complimented many on the beauty and craftsmanship of their regalia. Neither of them had ever been to a Pow Wow before. I had many opportunities to speak to him and James about several issues concerning our Tribe: Line

5, the lack of detox facilities in the UP, jurisdictional issues, the Farm bill, the drug epidemic, children in foster care....I specifically spoke to him about the reauthorization of the Violence Against Women Act and the additional items that have been included in it that we fully support. I told him that as he danced in the arena and looked out at our beautiful women and girls, he saw why we desire so strongly to protect them. I said it was his duty to as well and urged him to help us anyway he could to do it. He also met many members and had great conversations with them as well.

 I attended the annual US Attorney meeting on August 1 along with several staff and Council members. This meeting is an opportunity to meet agents from the BIA, FBI, DEA, Homeland Security, IRS as well as the Interim Assistant US Attorney and his staff. Sean Lewis who has recently been appointed to the position of Tribal Liason was also there. We spoke at length about the federal government's position on marijuana and how Tribes are treated very unfairly compared to states. We asked for any financial assistance that could be given to assist us in dealing with the drug epidemic on our reservation. Information was given on trainings available to our departments and we asked for specific education session for our community. One is being planned for the week of September 3. It will deal with the signs and symptoms of drug abuse, what to do when you suspect use and what resources are available to help that individual. We also asked for help with the US Highway 41 speed limit issue. I'm not sure that the Tribal Liaison clearly understands the jurisdiction on our reservation and will be providing him with a copy of the Bell Decision.

The results of the Secretarial Election held on July 17, 2018 which was entirely by mail out ballot is as follows: The proposed Amendment A, to add Article IX, Judicial Branch to the KBIC's Tribal Constitution was duly adopted by a vote of 101 For and 82 Against and 0 cast ballots were found spoiled in which at least 30 percent of the 274 registered voters cast their ballots in accordance with Section 16 of the Indian Reorganization Act of June 18, 1934, as amended.
